The Federal Ministry of Health, will receive an endowment fund from Commercial Bank of Ethiopia towards the cost of New Health Centers Construction for Five Regions located at Amhara (West Gojjam Zone, Mecha Woreda, Merawi town, Abyot Fana Kebele), Oromia (East Wollega Zone, Gida Ayana Woreda, 02 town, Angergute Kebele), Gambela (Itang Special Woreda, Itang Town, Lear Kebele), SNNP (Sheka Zone, Yeki Woreda, Masha Town, Fide Kebele) and Tigray (Hawulti Kifle ketema, Mekele City, Adushundun Kebele). The payments under this Contract for the construction of New Health Centers will be effected by Commercial Bank of Ethiopia.

2. Federal Ministry of Health invites sealed bids from eligible and qualified bidders for the Construction of New Health Centers.
3. Bidding will be conducted through the National Competitive Bidding (NCB) procedures specified in the Government Procurement Guideline and are open to all bidders from eligible source countries as defined in the Guidelines. Interested Bidders should fulfill the following requirements:
  - a. Contractor's registration certificate from the Ministry of Urban Development & Construction GC/BC-6 and above.
  - b. Renewed trade license valid for the year 2007 E.C
  - c. Registration Certificate in the suppliers list under Public Procurement and Property Administration Agency for the year 2007. Bidder can print from the PPPA website
  - d. VAT registration certificate.
  - e. Tax clearance from Inland Revenue Authority
4. Required Works: Construction of New Health Centers.

6. A complete set of Bidding Documents in English language may be purchased by interested bidders on the submission of a written Application to the address below and upon payment of a non refundable fee of Ethiopian Birr 500.00 (Five Hundred Birr).
7. Bids should be delivered to the address below on or before 2:00 PM on March 20, 2015. Electronic bidding will not be permitted. Late bids will be rejected. All bids must be accompanied by a Bid Security of Birr 50,000.00 (Fifty Thousand Birr) and must be in the form of CPO or Bank Guarantee from any Bank of Ethiopia.
8. Bids will be opened in the presence of the bidders' representatives, who choose to attend in person at Finance and Procurement Directorate Meeting Hall, Ministry of Health, Addis Ababa, at 2:30 PM on March 20, 2015.
