The Government of the Federal Democratic Republic of Ethiopia has received a Credit from the International Development Association (IDA) towards the cost of Urban Local Government Development Program (ULGDP II), and the Dire Dawa City Administration intends to apply part of the proceeds of this Credit to eligible payments under the contract for the procurement of Gravel road Construction Work.
2. The Construction and Municipal Service Bureau, ULGDP UNIT of the Dire Dawa City Administration now invites sealed bids from eligible bidders, Registered by the Ministry of Urban Development and construction with Category GC-7, BC-7 or RC-7 and above, renewed for the year 2014/15 (2007 EFY), able to submit Tax clearance and VAT registration certificates, for the construction and completion of Gravel road Construction Work.

Contract Identification No; ULGDP II /DD/CW-02/14/15.

The Works Comprise: The Construction of all whether gravel road and Storm water drainage work, mainly consists of Construction of Earth works, Construction of Granular sub-base, Construction of gravel wearing course, Construction of new Pipe, Slab/Box culverts, Provision of Side drains, Construction of cement mortared masonry stone, along the selected roots in Dire Dawa different kebeles.

3. Bidding will be conducted in accordance with the Open National Tendering Procedures contained in the Public Procurement Proclamation of the Federal Government of Ethiopia and is open to all bidders from eligible source countries.
4. To qualify for the award of contract the Bidder is required to full fill the minimum qualification criteria's, which are a general experience of five years, a particular experience of performing at least two work of similar nature, and a minimum average annual turnover of One and half times the bid price.
5. Interested eligible bidders may obtain further information from Construction and Municipal Service Bureau, ULGDP UNIT and inspect the Bidding Documents at the address given below at 10(a) from 07:30 A.M. - 05.30 PM. (Local Time).

A complete set of bidding documents in English may be purchased by interested bidders on the submission of a written application to the address given below at 10(b) and upon payment of a non-refundable fee of Birr 300.00 (Three Hundred Birr). The method of payment will be cash or cashier's check.
7. A Pre-Bid meeting will be conducted in the presence of bidders or their authorized representative who choose to attend at 09:45 AM. (Local Time) on February 27, 2015 at the address given below at 10(c).
8. Bid must be delivered to the address below at 10(d) at or before 09:00 A.M. (Local Time) on March 10, 2015 and must be accompanied by a Bid Security of Birr 150,000.00 (One Hundred Fifty Thousand Birr). Electronic Bidding will not be permitted and Late Bids will be rejected.
9. Bids will be closed at 09:00 AM. (Local Time) March 10, 2015 and opened in the presence of bidders' or their authorized representatives who choose to attend in person at address below at 10(e) at 09:15 AM. (Local Time) on March 10, 2015.
