1. The Federal Democratic Republic of Ethiopia Pharmaceuticals Fund and Supply Agency (PFSA) invites all interested bidders to submit their bids for the Pharmaceuticals indicated in the bid document.

2. Bidding will be conducted through the international competitive bidding procedure specified in the PFSA's procurement Guideline and is open to all bidders from eligible source countries as defined in the Bidding document.

3. Qualification requirement:

Bidders must produce copy of product registration certificate issued by Food, medicine and Healthcare Administration and Control Authority (FMHACA) of Ethiopia before the bid closing date and hours.

In case of suppliers who are invited without having FMHACA product registration certificate;

- i) bidders shall submit affirmative FMHACA GMP inspection report if any or
- ii) GMP and FSC certificate from authorized body in the country of origin.

Evaluation criteria for items:

Bidders may bid for items they invited. Bids will be evaluated for each item and the Contract will comprise the item(s) awarded to the successful Bidder.

6. Bids must be delivered to the address below on or before March 17, 2015, 2:00 PM local time. Late bids will be rejected. Bids will be opened in the presence of bidders or their representatives, who choose to attend in person at the Conference Hall of Pharmaceuticals Fund and Supply Agency, Addis Ababa, Ethiopia at March 17, 2015, 2:30 P.M local time.
7. Bid must be accompanied by a fixed Bid Security: The bid security can be submitted in USD or its equivalent in a freely convertible currency. Refer bid documents about the amount of bid security.
