It is open to all Domestic Contractors as indicated in the above table licensed as Water Works Construction/WWC 6/General Construction/GC 6/ and Above having valid license for the fiscal year 2007E.C.

A complete set of bidding documents can be purchased from OIDA, A.A.; Churchill Road in front of Lise Gebere Mariyam School Kobil Fuel Station Building at 1st Floor procurement section with submission of a written request and payment of a non-refundable fee of Eth, Birr 200.00 (Two hundred only) for each document. The method of payment will be in cash only. Interested bidders may obtain further information from Oromia Irrigath Development Authority.
6. In this bid No Price adjustment will be allowed up to the end of the construction.
7. Bids shall be valid for a period of 120 days after bid closing and must be accompanied by a bid security of the amount stated above in the form of cash payment Order (CPO) or Bank guarantee only during submission of the bid.
8. Bids must be delivered to Oromia Irrigation Development Authority, Meeting Room on the Top of the Building on or before 29/01/2015 day at 10:00am Morning and opened on the 30th Calendar days after the First Bid announcement is posted on Newspaper. And opened on the same date mentioned above at 10:30 am Morning in the presence of the bidders or their representatives who Choose to attend. Late bids will be rejected.
9. Bid has to be submitted according to the instruction stated on the bid document.
10. Bidders have to visit the site and bring site visit evidence from Zone or District Irrigation office or from the project kebele according to the site visit format. OIDA can consider this as rejection point or as compliance based on common availability.

11. One original unit rate analysis, which considers the current market, signed and sealed has to be submitted.
12. Bidders could participate on 2 /Two/ Projects but the office award only 1 /One/ Project but Looking at past Experience, the client has the right to award additional Projects.

OIDA reserves the right to accept or reject part or all bids.
