WHAT'S NEW IN INTERNATIONAL BUSINESS?

- A private Thai company plans to invest \$275 million in a new solar power project with a
 generating capacity of 210 megawatts, located 500 kilometers north of Yangon. The company is
 seeking expert and financially sound partners for the implementation of this project. Read more &

- The EU and US are planning to start manufacturing **wood products** in Myanmar since log exports will be stopped in 2014. Read more

SETTING FOUNDATIONS FOR A STABLE FINANCIAL SECTOR

 Myanmar is planning to open three new banks focusing on customers from the jewelry and construction businesses. Read more The Thai KBank has signed a deal with Myanmar CB Bank to allow Myanmar nationals in Thailand
to transfer funds to their homeland via KBank ATMs. This follows a similar deal closed recently
between Thai SCN and Myanmar Kanbawza Banks. KBank has also set up a representative office
in Yangon to provide services to Thai investors there. Read more

MYANMAR'S ECONOMY AND FOREIGN AID

- The European Union foreign ministers unanimously decided to permanently ended sanctions
 against Myanmar. This decision comes shortly after a support package of 150 million Euros was
 committed by the EU in March to support Myanmar's reform. Currently, only an arms embargo
 remains for one more year. Read more
- **Japan** wrote off nearly 2 billion dollars in debt and announced an aid package of 500 million dollars to support the country's reform. Read more
- Myanmar is drafting a five-year plan to develop the country's dairy cattle breeding sector. The
 New Zealand government has offered assistance in this project. The minister of livestock and
 fisheries stressed the need to establish dairy cattle breeding farms and value-adding dairy product
 factories. Read more
- The U.S. has proposed \$75M in aid to Myanmar for 2014, to encourage the government to continue with its reform. Read more
- **Israel** and Myanmar will increase agricultural collaboration, following a meeting between Israeli ambassador and Myanmar minister for agriculture and irrigation. Read more

FOR THE POTENTIAL INVESTOR

- Myanmar will host a global summit on agriculture, investments and infrastructural development
 in Yangon in June 2013. The summit will be attended by ADB, FAO and local NGOs as well as
 officials from local ministries. More details
