3. Bidding will be conducted through the National competitive bidding (NCB) procedures specified in the Bank's Procurement guidelines under AfDB grants and is open to all eligible national contractors as defined in the guidelines.
4. The interested contractors has to provide information, available construction tools such as, Vibrator, Mixer and Vehicle, available skilled, and semi-skilled man power and other relevant information as specified in the bid document.
5. The interested bidders will be requested to offer technical and financial proposals separately specified in the bid documents to be provided. Bids must be accompanied by bid security amount stated on table above in unconditional Bank guarantee or CPO. Electronic bidding will not be permitted and late bids will be rejected. Bids shall be valid for period of 120 days after bid opening.
