

Re-INVITATION TO BIDS National Competitive Bidding

To all eligible bidders of renewed license valid for the year 2005 E.C.

1. The ORGANIZATION OF OROMIA STATE BUILDINGS ADMINISTRATION/ ADAMA BRANCH/ABA GEDA has a secured budget from the National Regional State of Oromia to be used for the procurement of SYSTEM MAINTENANCE WORKS.
2. The ORGANIZATION OF OROMIA STATE BUILDINGS ADMINISTRATION ADAMA BRANCH/ABA GEDA now invites wax-sealed bids from eligible bidders who are interested and capable to allocate their sufficient resources for SUPPLY OF SPARE PARTS & MAINTENANCE OF LOT 1 (SOUND SYSTEM), LOT 2 (AIR COOLING SYSTEM) & LOT 3 (GENERATOR).
3. Bidding will be conducted in accordance with the open national tendering procedures contained in the Public Proclamation of the Federal Democratic Republic of Ethiopia and is open to all eligible bidders.
4. Interested eligible bidders may obtain further information from the address stated below.

The bidders shall submit one big wax-sealed bidding document which encloses the original bid document and copy of the bid wax-sealed inner envelopes duly making the inner envelopes as "Original bid document" & "Copy of bid document". The Original bid document includes both the "Original Technical Proposal" and "Original Financial Offer" and duly marking as the same and wax-sealed separately. The copy should be photocopy of the original bid document and must be sealed and marked in the same manner as the original bid document. The bid security must be wax-sealed separately and must be put in the original technical proposal.
6. Both bids (financial and technical) must be deposited in the tender box prepared for this purpose.

A complete set of bidding documents in English may be purchased by interested bidders on the submission of a WRITTEN APPLICATION, VAT REGISTRATION CERTIFICATE & TRADING LICENSE to the address given below and upon payment of a non-refundable fee of Ethiopian Birr 200 only in cash starting from February 11, 2013, 08:30 A.M. to March 1, 2013, 02:00 P.M. during office hours.
8. Bids must be delivered at or before 12:00 A.M. on March 4, 2013 and bid will be opened on the same day at 2:30 P.M. in the presence of the bidders' representatives who choose to attend. And the bid is valid for 90 days after bid submission deadline. All bids must be accompanied by a bid security of 1% of total bid price for each lot which will be payable on the first demand to client security in acceptable form of CPO and bid security must be addressed to the employer. Late bids shall be rejected.
