

INVITATION TO BID

To All contractors of category GC/BC, Class 1 with license valid for the year 2005 E.C and can present Short term Regional Registration Certificate for construction work service of Gondar Zonal Hospital.

1. The Amhara National Regional State Health Bureau has invited properly sealed bids comprising of Technical & Financial Proposal from eligible Bidders for Providing necessary labor, material & equipment for construction and completion of Gondar Zonal Hospital at Gondar Town.
2. Both the pre-qualification (Technical) and non priced (Financial) bid documents may be obtained by any interested eligible bidders on the submission of a written application to The Amhara National Regional State Health Bureau.

Each bid must be accompanied by an acceptable bid bond (CPO) in the sum equal to 2% of the bid amount including VAT and must clearly state the bidding hospital and employer, the bid bond amount shall not exceed birr 500,000 (five hundred thousand) which shall remain in forces for 90 calendar days from the bid opening date and shall be in separate envelope. The successful bidder will be required to furnish a performance bond in the sum of 10% of the gross bid sum within 15 days from signature.
 4. Bidders are warned that they must read and comply in full with the INSTRUCTION TO BIDDERS"
 5. The construction of works shall be completed within a maximum of 608 Calendar day.
 6. All bids must be submitted based on the free market price, and current basic materials price must be attached with the bid document.
 7. Both the pre qualification and priced bid documents shall be in separate envelopes & properly sealed (one original & one copy)
 8. All Bid will be Evaluated based on Technical evaluated & financial least bidder.
- Sealed pre-qualification & priced bid documents shall be submitted to the ANRS Bureau of Health Room Number- 18 on or before 45 Calendar day from the first advertisement at 2:00 PM and shall be publicly opened at 45 calendar day starting from first advertisement date /The Ethiopian Herald/ at 3:00 P.M. If the opening date lies on holly day it will be shifted to the next working day in ANRS Bureau of Health when the name of bidders and the amount of their bids will be declared. Bidders are advised to attend the opening of bids.
