6. Qualification requirements include: technical, financial, & legal documents. A margin of preference for certain goods manufactured domestically "shall not" be applied. Additional details are provided in the bidding documents.
7. A complete set of bidding documents in English may be purchased by interested bidders on the submission of a written application to the address below and upon payment of a non-refundable fee of three hundred (300) Birr. The method of payment will be in cashiers' check or in cash.
8. Bids must be delivered to the address below on or before March 15, 2013, 2:00 P.M. Electronic bidding will not be permitted. Late bids will be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend in person at the address below on March 25, 2013 at 2:30 P.M. All bids must be accompanied by a "Bid Security" or "Bid Securing Declaration," of forty thousand (40,000) Birr for Lot one & twenty thousand (20,000) Birr for Lot two or an equivalent amount in a freely convertible currency.
