Burkina Faso has received funding from the World Bank to finance the Urban Infrastructure Transport and Development Project (PTDIU), and intends to use part of these funds to make payments under the contracts relating to the development and asphaltting works of 7 km of urban roads in Ouahigouya. The activities of the PTDIU are administered and coordinated by the Permanent Secretariat of the Sectoral Transport Program (SP-PST) headed by its Permanent Secretary, who has full responsibility for managing the implementation of the Project.

2. The Burkina Faso Infrastructure Works Agency (Agetib), as Partner Agency for the implementation of the project, requests, on behalf of the Permanent Secretariat of the Transport Sector Program (SP-PST), closed on the part of eligible bidders and meeting the qualifications required for carrying out the development and asphaltting of urban roads in Ouahigouya divided into two (02) lots as follows:

Lot 1: Development work on seven (07) km of urban roads in the commune of Ouahigouya in two-layer surface plaster including the sewerage network and the creation of horizontal and vertical signage;

Lot 2: Construction work for solar public lighting (supply, installation and commissioning of a single stick candelabra on a line of 6,119 ml and a double stick on a line of 889 ml) on a line of seven (07) km of urban roads in the commune of Ouahigouya.

Execution times: six (06) months for each lot.

3. The procedure will be conducted through international competition by using an International Invitation to Tender (AOI) as defined in the “Directives: procurement of supplies, works and services (other than consultancy services)) by World Bank Borrowers in connection with IBRD Loans and IDA Credits and Donations ”, from January 2011 and revised in July 2014 and open to all bidders from eligible countries as defined in the Guidelines .

Interested and eligible Bidders can obtain information at the address below from 7:30 a.m. to 12:30 p.m. and from 1:00 p.m. to 4:00 p.m. every working day.

3. The Instructions to Bidders and the Administrative and General Clauses Notebooks are those of the Standard Bidding Document for Works - Civil Law of June 2012, version revised in January 2017 with the aim of strengthening environmental and social performance and in terms of health and safety.

5. The French Tender Documents can be consulted free of charge at the address below and purchased by any interested Bidder at the address below against the non-refundable payment of one hundred thousand (100,000) F. CFA. The payment method will be made by direct deposit of the purchase amount of the CAD in the bank account opened in the name of AGETIB n ° 01001 00100053312-10 at BSIC-Burkina. The withdrawal of the Tender document will be from the Agetib procurement department upon presentation of the receipt for payment of the purchase amount of the CAD.

6. Offers must be delivered to the address below no later than January 15, 2020 at 11:00 a.m. GMT. The submission of tenders by electronic means will not be authorized. Any offer received after the expiry of the deadline for submission of offers will be rejected. Tenders will be opened in the presence of the representatives of the tenderers and of the persons present at the address mentioned below on January 15, 2020 at 11:15 am GMT.

7. Offers must be accompanied by an offer guarantee, in the amount of:
- Lot 1: seventy-five million (75,000,000) CFA francs;

- Lot 2: eight million (8,000,000) CFA francs.
