INTEGRATED DEVELOPMENT AND MANAGEMENT PROGRAM FOR THE GURU WATERSHED

1. This Notice of invitation to tender follows the General Notice of Procurement published in the Official Bulletin of Public Markets of Côte d'Ivoire No. 1471 of July 31, 2018.
2. The Ministry of Sanitation and Sanitation requested and obtained funds from the West African Development Bank (BOAD) in order to finance the partial cost of the Gourou Watershed Planning and Integrated Management Project in Abidjan, and intends to use part of these funds to make payments under the Sewage Treatment Works Contract on the watershed. The Works will be carried out in Côte d'Ivoire within eighteen (18) dry months (excluding rainy seasons). Any offer proposing a deadline for execution of the work greater than 18 months will be rejected.
3. The Ministry of Sanitation and Health through the Program Management Unit (PMU) solicits closed offers from eligible candidates who meet the qualifications required to perform in the Municipalities of Adjamé and from Cocody to Abidjan the following works spread over five (5) sites (Angré, Sideci Nord, Sideci Sud, Adjamé sector 1 and Adjamé sector 2) in a single lot: Supply and laying of wastewater pipes (5,840 ml) and Realization 112 specific connections - Supply and installation of prefabricated lifting stations - Construction of a pumping station of 850 l / s; no variant can be taken into account. The Bidder will fill in the unit and total prices for all the items in the Price Schedule and in the Quantitative and Estimated Details.

Participation in this open call for tenders as defined in the Guidelines for the award of works, goods and services (other than consultancy services) financed by a loan or a cash advance from BOAD, is open to all eligible candidates who fulfill the conditions defined in this Tender Document and who are not affected by the provisions of the Directives.
