Bidders are required to attach, with their application, a copy of their renewed trade licenses, VAT Certificate and Tax Identification Number Certificate.
5. The provisions in the Instructions to Bidders & in the General Conditions of Contract are the provisions of the African Development Bank Standard bidding document: Procurement of Goods and Works.

Bids must be delivered to the above office on or before 2:00 PM local time on 02/09/2013 and must be accompanied by a bid security of at least 1% bid price corresponding to the lots indicated in the above table or an equivalent amount in the form of CPO, unconditional Bank guarantee or in convertible currency.
