The Haramaya University now invites sealed bids from eligible and qualified bidders for the Construction of Sport Field which contains: a Foot Ball Field, one 3 in 1 courts (hand ball, basketball & volley ball), Landscaping work, and Access Road. The project location is at Haramaya University Main Campus located at 525 km east of Addis Ababa. The construction of the whole works shall be completed within 120 calendar days (Provided that before December 15, 2013 for the inter-University game computation) from commencement of works. Bidders should have successful experience in the execution of similar works in nature and complexity. Bidders should be registered contractors of category GC/BC class 4 and above having Trade license and construction service certificates valid for 2005 Ethiopian Calendar years, Tax clearance certificates, VAT Registration certificate. Interested eligible bidders are invited to submit Wax-sealed bids for providing the necessary labor, material equipment and any other necessary requirements for the execution and completion of the works.
3. The delivery period is 10:00 AM August 22, 2013.
4. Bidding will be conducted through the open national tendering procedures contained in the Public Procurement Proclamation of the Federal Government of Ethiopia, and is open to all bidders from Eligible Source Countries as defined in the bidding documents.
