

#### **Glucosamine sulfate**

Buffering action, helping to avoid pain caused by friction of joints and helps to increase the amount of cartilage and synovial fluid and prevent damage.

#### Methylsulfonylmethane (MSM)

Natural source of sulfur, analgesic and anti-inflammatory. Increases joint lubrication.

#### **Chondroitin sulfate**

Gives cartilage its mechanical and elastic properties. It acts as a vehicle for nutrients and growth factors. Chondroitin sulfate has proved beneficial effect in the treatment of osteoarthritis.

#### Turmeric (Curcuma longa)

Has positive effect on bone remodeling and in improving the mechanical strength of the bone. Effective in reducing pain caused by osteoarthritis due to the ability to reduce inflammation. In the case of rheumatoid arthritis it appears that turmeric could help reduce some of the symptoms of this disease.

#### Zinc citrate

Has analgesic effect during the early stages of inflammation and is also suitable for the symptomatic relief of certain anti-inflammatory joint diseases.

#### Manganese gluconate

Helps form connective tissue and bones and is important for calcium absorption. Combined helps reduce bone loss in the spine in older women.

**Rosemary** contains carnosol, one of the majority components of the plant, with anti-inflammatory properties related to the inhibition of the nitric oxide and the inhibition of inflammatory cytokines. Externally applied. It helps the muscular recovery and to relieve the pain. (Emami F et al. 2013)

**Glutamine** is an amino acid present in a majority form in our organism. After exercise acid levels have decreased significantly, so that an input of glutamine favors the correct recovery of the muscle. It helps to neutralize the effect of acid in the muscle (dos Santos RV. 2009).

It contains allantoin. It helps to improve the absorption, acts healing, stimulating and regenerating.



• The level of a mineral: is the amount of mineral that contains the salt.

In this way, calcium glycerophosphate is one of the six salts that has the highest bioavailability due to its similarity of composition with phospholipids in the membrane. Hydroxyapatite combines high calcium levels and bioavailability, since it is the microcrystalline form of calcium in human bone. Besides, the hydroxyapatite exerts an antagonistic effect on PTH (parathormone) by inhibiting demineralization of bone.

**Calcium (Ca)** is an essential mineral for the functioning of our cells. In our organism it can be found in ionic form or forming part of the skeleton:

- Calcium in its free ionic form (Ca2 +): acts as cofactor in many reactions enzymes (such as those of phosphorylation performed by kinases), is involved in blood clotting and regulates muscle contraction (along with potassium and sodium) and the endocrine and exocrine glands.
- Calcium in the form of hydroxyapatite [Ca10 (OH) 2 (PO4) 6]: rigid structure of calcium phosphate that wraps the protein matrix of the bones, protecting them and providing its mechanical and supporting properties

**Vitamin D** is a group of fat-soluble vitamins, active vitamin D3 is synthesized in our body through different oxidation reactions, giving rise to the following compounds:

- Colecalciferol: is synthesized in the skin when taking the sun or we can ingest it with supplements.
- Calcidiol: is a pre-hormone inactive in blood synthesized in the liver.
- Calcitriol: is the active form of vitamin D3 and is synthesized in the kidneys. Calcitriol's main function is to increase the absorption of calcium in the intestine and reabsorption in the kidneys.

**Phosphorus (P)** is a mineral, the metabolism of which is interrelated with that of calcium, since most of it is forming the mineral part of the bone. absorption is parallel to that of calcium, depending also on vitamin D3. An adequate concentration of phosphorus is necessary for a correct mineralization.

In addition, free phosphorus participates in numerous functions, such as muscle contraction, (ATP), forms part of cofactors (NADP) and is involved in enzymatic systems (adenylate cyclase).

**Dried bamboo extract** is rich in silicon (Si), a mineral that is part of the molecules (proteoglycans, hyaluronic acid, etc.) and the main fibers (collagen and elastin) that form the connective tissue. This is the most important tissue in many of the structures of the locomotor apparatus, such as bones, tendons and ligaments.

In addition, silicon intervenes in the regulation of the processes of cellular division of the connective tissue, activating the repair and renewal.




